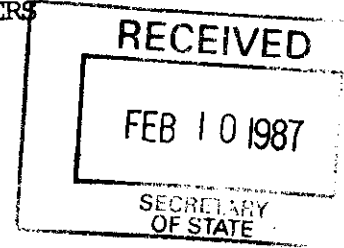

We, the undersigned, desiring to form a non-profit corporation under the laws of the State of Alabama, for the purposes hereinafter set forth do hereby make and subscribe our names in token to this certificate and do hereby certify as follows:

I

The NAME of this corporation shall be Society of Amateur Radio Astronomers.

II

The DURATION of the corporation shall be PERPETUAL.

III

The Society will be a non-profit organization operated to promote scientific research in the field of radio astronomy. Its aim is to provide a forum for the exchange of ideas, techniques, and project planning among amateur radio astronomers and other interested persons. To publish and disseminate information and literature on the subject of radio astronomy, all purposes to be those within the meaning of Section 501(c)(3) of the Internal Revenue Code.

The address of the corporation shall be 725 Inwood Road, Montgomery, Alabama 36105, and the agent of said corporation shall be John R. Weiss at this address.

VI

The affairs of the corporation shall be managed by a Board of Directors of not less than six (6) or more than twelve (12) directors. The By-laws of the corporation shall fix the number of directors, the method of electing the directors as well as the term of an elected director and the duties of the directors. The By-laws of the corporation shall provide for the number of officers of the corporation, the method for electing such officers, the terms each elected officer shall serve and the duties of the officers.

The By-laws of the corporation shall be adopted, amended, altered or rescinded by the membership at a regular annual meeting or at a meeting specially called for such purpose.




IX

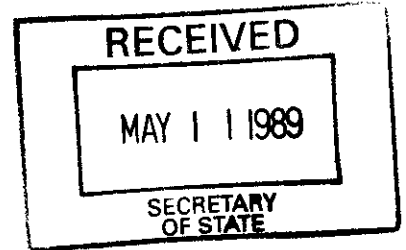

AMENDMENTS TO ARTICLES OF INCORPORATION
OF
SOCIETY OF AMATEUR RADIO ASTRONOMERS
AN ALABAMA NON-PROFIT CORPORATION

To the Honorable Walker Hobbie, Judge of Probate
of Montgomery County, Alabama

Pursuant to the provisions of Section 10-3A-81 of the Code of Alabama the undersigned non-profit corporation adopts the following articles of amendment to its Article of Association.

FIRST: The name of this corporation is Society of Amateur Radio Astronomers.


SECOND: Article III of the Articles of Incorporation shall be amended by adding the following sentence:

Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue law.

THIRD: Article IX shall be deleted in its entirety and the following substituted therefore:

In the event of dissolution, the residual assets of the organization shall be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code, or to the Federal, State or local government for exclusive public purposes.
